CTV Board of Directors,

We have an opportunity to get a very affordable and fast fiber connection through our partnership with Satellite. Satellite has several coworking centers on Comcast fiber internet service. They get a volume discount and we can be folded into that contract and receive the discount.

Currently we are not competitive in this area. The Cruzio coworking center has a fiber connection. Some of our digital media clients leave our space and go there to upload their video files. Nextspace will surely go to fiber now that is available downtown businesses at a low introductory rate.

Elana tells me she gets frequent requests for faster connections and that we recently lost a long-term office client due to our slow service. As one of our target markets is media creators, it is important to provide a connection fast enough for them to send high-resolution files.

It's in CTV's best interest to be on the cutting edge in this arena. Fiber service requires a 60-month contract. We don't want to sign up for a service that will be out of date in 60 months. Comcast has agreed to let us move between 100 mbps and a gigabyte as needed, within the same contract. There will be no penalties /fees for up or down grading the service.

We have compared a quote for Cruzio fiber with the Comcast quote through Satellite. When you factor in the cost for construction and that we would need to start at the gigabyte level with Cruzio, the Comcast quote is more cost effective and flexible.

We'd like to start with 200 mbps and move up or down as needed.

Comcast fiber quote:

100 mbps symmetrical \$795.00 60 months. 200 mbps symmetrical \$1100.00 60 months 300 mbps symmetrical \$1300.00 60 months

- The service can be dynamic
- No penalty for exiting our current contract
- We can move between 100 mbps and a gigybite as needed w/o penalty

CTV can afford to make this change in order to serve our members and client better. We would like to move forward as soon as possible as construction will take some time.
